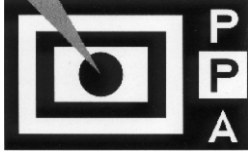

## STANDARD TERMS & POLICIES

It is fully understood that this studio is the exclusive photographer. Others, either amateur or professional will only be permitted at our discretion.

### PHOTOGRAPHY PAYMENT SCHEDULE

1. \$200 Initial Deposit for Photography Services
2. One-half of the remaining balance is due 60 days prior to wedding date.
3. Remaining balance due upon Preview completion. (web, magazine or preview album).
4. All reprints must be paid in full upon order. Overdue accounts (+30 days) may at our discretion, be referred to our collection agency for payment.

### CANCELLATIONS & POSTPONEMENTS

All cancellations and postponements **must** be made in writing. Phone calls are not acceptable. A "Liability Release" will be sent to client to legally cancel the agreement. Upon cancellation, a six month credit period is issued. Should a rescheduling occur, current prices apply, but all monies are still useable, pending availability, which cannot be guaranteed, thus all monies paid are not refundable. In the event of a cancellation, ALL monies paid. Any deposit is not transferable. This agreement is automatically cancelled if deposit is not paid in 5 business days.

### PRICING

All prices quoted are guaranteed until the delivery of the wedding previews. Final reprint choices are to be made within 90 days. After 90 days prices may escalate to prevailing prices.

### MODEL RELEASE

Ron Emser Photo-Graphics reserves the right to use any and all photography taken at your wedding for promotion and/or competition. Signing of this contract constitutes a full model release on the part of all persons/places/property photographed.

### LIABILITY RELEASE

This studio takes the utmost care humanly possible with regards to exposure, development, and delivery of photographs. However, in an event of failure due to any event/act within the control of the studio, the studio's liabilities are limited to refund of monies only, minus expenses. Liability for any event/act outside the control of the studio will not be accepted. All coverage time/weather permitting. The photographer's interpretation of your wedding and all of its acts/events is final. No additional liability can and will be accepted.

Please include the photographer and assistants to be fed at the reception, along with guests. We cannot be responsible for any missed events in order for the photographer to leave for dinner.
